| Approval of last meeting minutes (Action Item) | No previous minutes to approve. |
| Topics to Discuss: <ul style="list-style-type: none"> Rural Crisis Response project discussion with Ross Edmonds, Boise H&W | <p>Funding: Ross explained the extent of the funding available for start-up would be \$200,000. Once we are established and serving clients, then we can begin billing monthly for those services. Our previous budget had been submitted with a request for additional funds beyond the \$200,000. Carol will re-do the budget and share with the committee for our next call.</p> <p>Billing capacity: Ross said it was OK to begin planning for future billing, but he would prefer that we stay connected with the Crisis Centers across the state as they are looking at a “Reconciliation” process where we could negotiate with local payers to reconcile the amount that the hospitals have contributed to crisis care. The crisis center legislation says that clients will not be billed for the services. There will be no CPT billing to clients, even if they have insurance.</p> <p>Staffing: Ross expressed concerns about our model for using PRN staff to assist with the crisis rooms. He would like to have us to ‘strawman’ the process for services and get that to him for review, before any further contract negotiations can happen.</p> <p>Hallmarks: There are hallmarks of crisis centers that H&W require for consistency across all models. Teresa will find these hallmarks and share with the committee.</p> |
