- Update on Senior Housing Project Loren Beauchamp, Manager, Interlink Volunteer Agency
 Loren will be contacting Barb Leachman to further discuss her history when she worked for Community
 Action. She has experience in setting up Sr. Living. Loren is surveying Interlink population to see what
 the need is for the Sr. population
 Barb stated that when she was working and developing Sr. housing they developed a needs analysis
 document. She was able to use direct subsidies for housing. A building to check out during the building
 of Sr. living is located at 1515 23rd Ave.
- Update on sober house in Lewiston Shaun Hollace Mens sober house in Lewiston will be transitioning to a female house. In Lewiston there is the Rising Sun and Oxford House and Shaun and his partner have a sober house. Shaun spoke with his board to open a temporary warming shelter. He will need the building and would need to be temporary and ancillary use.
- Update on Lewiston Schools homeless families Lisa Martin for Cynthia Nunez
 Cynthia is out of town for training and asked to report that there are 110 students in the school district who are homeless. It's becoming more difficult for families to find housing.
- Tentative update on Union Gospel Mission Ken Miller We are into the 4th year in planning UGM to come into the area. UGM has a conditional use permit and a builder lined up and into the Capital Fundraising campaign. So far ¼ of the funds have been raised. Possibilities for additional funds may be from the local churches and community members. The public campaign will begin at the first of the year. Tap into the LC Advisory committee as to what UGM will need. UGM will approach churches for presentations. Half of UGM will be for women and children.
- Discussion regarding Lewiston warming shelter Michelle King

Councilor Tousley reported that the City is wilingl to open up the Community Center for a temporary warming shelter. Michelle asked about the 2nd floor of the Library could be considered. It's ADA compliant and is a manageable space.

Loren reported that he has an unfinished basement to open up for emergency housing andt asked if anyone was aware of funds to finish the space. Councilor Tousley will look into space that the city may be able to allow for temporary space for a warming shelter. Would the Shopco parking lot work?
